Boards and Commissions



The City of Fayetteville relies on its citizen advisory boards and commissions to aid its Mayor and City Council in governing effectively. The citizens who volunteer for these positions are the link that connects the public to its governing body and are the advisors who make recommendations that ultimately shape the future of Fayetteville. Herein, you will find information on the City of Fayetteville boards and commissions.

Thank you for your desire and interest in serving our community.

MEMBERSHIP AND ATTENDANCE:

It shall be the policy of the City Council to allow an individual to serve on no more than two boards or commissions at a time; providing that one of the two Boards and Commissions meet on an "as needed" basis. Pursuant to City Code § 2-35 (c), an appointee shall attend at least 75 percent of regularly scheduled meetings, special meetings and other activities of the board or commission, such as special events and sub committee meetings where applicable on an annual basis from the date of their appointment and that if an appointee does not comply with such attendance, or fails to attend three (3) consecutive regularly scheduled meetings, then the appointee shall be automatically removed and not be appointed to any City board or commission within two years of their removal date. Cancelled meetings shall count as an attended meeting. The City Clerk shall notify the appointee and report to the City Council by letters if an appointee has been removed pursuant to this provision.

Employees of the City of Fayetteville may only serve on a board or commission when specified by the City Council.

AIRPORT COMMISSION

The Airport Commission administers the operation and maintenance of the Fayetteville Regional Airport.

COMMUNITY POLICE ADVISORY BOARD

The board is to provide sound advice and recommendations to the City Council, City Manager, and Police Chief to improve the quality of policing in Fayetteville in a cooperative effort between the community and the police by reviewing and recommending policy enhancements to better meet the needs of the community, provide and support a training curriculum that allows for police and community experiences to be shared and understood with greater context, and analyzing existing public records all of which results in improved perception of procedural justice, and enhanced trust of the police.
